**HOW TO EXERCISE WITHDRAWAL RIGHTS CORRECTLY**

Under the applicable laws in force and the Sales Conditions you accepted on making your purchase, the exercising of withdrawal rights is subject to the following conditions:

- 1) This form must be filled out correctly and sent, within 14 (fourteen) days from receiving the returned goods, to the following e-mail address [customer.stellajeans@sinv.com](mailto:customer.stellajeans@sinv.com) If the Goods were sent by the Vendor, the latter shall send the "RETURNED GOODS CODE" by e-mail.
- 2) Within the same term of 14 (fourteen) days from receiving the "RETURNED GOODS CODE", the "RETURNED GOODS CODE" must be entered in the code field and the form attached to the goods to be returned to the following address

i.e. to the carrier assigned to returning the goods

If the return process involves more than one product, they must all be returned together and/or in the same shipping lot to P.S. S.p.A. It is also mandatory for:

- a) the product to be intact;
- b) the product to be returned in its original packaging;
- c) **the goods are accompanied by the form referred to in section 1 above, complete with the "Returned Goods Code"**

When you exercise your legitimate right of withdrawal, P.S. S.p.A. shall refund you with price paid the goods, including the first shipping costs, within 30 (thirty) days from acknowledging the exercising of such rights.
